I acknowledge that my participation in circus arts, aerial arts, aerial silks, Pilates, aerial yoga, yoga, acrobatic training, jumping, trampoline activities, and instruction activities includes known and unanticipated risks that could result in physical or emotional injury, paralysis, or death and damage to myself, to property, and to third parties. I understand that such risks simply cannot be eliminated without jeopardizing the essential qualities of the activity, and that the risks include every type of injury, both psychological and physical, including scratches, cuts, lacerations, sprains, strains, fractures, concussions, and even more severe life threatening injuries to my head, neck, back, and internal organs. I also acknowledge that there is a risk of injury resulting from the negligent conduct of other people participating in any activity at MY Studio. \_\_\_\_\_ (initial)

Furthermore, I acknowledge that MY Studio employees have difficult jobs to perform, that they strive to provide safety for all at MY Studio, but they are not infallible. They might be unaware of my fitness or abilities. They may give incomplete warnings or instructions, and the equipment being used might malfunction. \_\_\_\_\_ (initial)

I expressly agree and promise to accept and assume all of the risks associated with any activity in which I take part at MY Studio. My participation in any activity at MY Studio is purely voluntary, and I elect to participate in spite of risks. \_\_\_\_\_ (initial)

In the event that I file a lawsuit against MY Studio, I agree to do so solely in the state of Arizona, and I further agree that the substantive law of Arizona shall apply in that action without regard to the conflict of law rules of Arizona. I agree that if any portion of this agreement is found to be void or unenforceable, all other terms of this agreement shall remain in full force and effect. \_\_\_\_\_\_(initial)
